EXPLANATION OF PROPOSED AMENDMENT

EXPLANATION OF PROPOSED AMENDMENT

THE PROPOSED AMENDMENT WHICH TAKES EFFECT UPON APPROVAL BY THE VOTERS, AMENDS THE EFFECTIVE DATE OF LAWS SECTION OF THE 1970 ILLINOIS CONSTITUTION. THIS SECTION OF THE CONSTITUTION DETAILS WHEN BILLS SHALL TAKE EFFECT AND BY WHAT VOTE THEY MUST PASS THE GENERAL ASSEMBLY IF THEY ARE TO TAKE EFFECT EARLIER THAN SCHEDULED.

CURRENTLY, ANY BILL PASSED AFTER JUNE 30 CANNOT TAKE EFFECT BEFORE JULY 1 OF THE FOLLOWING YEAR UNLESS THE BILL PASSES THE LEGISLATURE BY A THREE-FIFTHS VOTE. PROPOSED AMENDMENT CHANGES THE DATE WHEN THE THREE-FIFTHS VOTE REQUIREMENT TAKES EFFECT FROM JULY 1 TO JUNE 1. AS A RESULT OF THIS AMENDMENT, ANY BILL PASSED AFTER MAY 31 WILL NOT TAKE EFFECT UNTIL JUNE 1 OF THE FOLLOWING YEAR UNLESS THE BILL PASSES THE LEGISLATURE BY A THREE-FIFTHS VOTE.
