When we began, the training had not been completed, but as of our final report, it is completed. A Whistleblower resolution was passed that had also been missing. In preparing this report, we reviewed several studies on local government efficiency. These studies show that:

- The average local government in Illinois serves 1800 residents compared to the national median of 2850 individuals
- Most townships in Illinois have no bonded indebtedness. Together with road districts
 they are an integral element of local democracy. Township expenditures have grown at a
 lower rate than those of any other level of government since 1992.
- Townships have lower labor costs and employ mostly part time employees.
