V. Findings

- 1. The district operates with lean staffing and relies heavily on volunteer personnel. Response times are within acceptable standards for rural areas.
- 2. Budget reviews indicated responsible fiscal management, with moderate reserves and a stable tax levy.
- 3. Apparatus are well-maintained, though some vehicles are nearing the end of their service life.
- 4. The district participates in mutual aid agreements and automatic response plans with neighboring departments, which have proven effective.
- 5. Volunteer staff receive regular training. Increased investment in continuing education is recommended.



6. Limited community engagement was noted. Consideration should be given to public education campaigns and increased online presence.

VI. Recommendations

- 1. Join regional or state cooperative purchasing programs for equipment and supplies to reduce costs.
- 2. Launch public safety awareness initiatives and improve social media communication.
- 3. Develop a long-term capital plan to replace aging vehicles and update facilities.
- 4. Actively pursue state and federal grants for training, safety equipment, and capital improvements.

VIII. Conclusion

The Decennial Efficiency Committee commends the Shoal Creek Fire Protection District for its commitment to responsible service and continuous improvement. This report will be submitted to the Montgomery and Bond County Boards and made available to the public as required.
