What Have We Done Well?

Our Township's efficiency has increased through intergovernmental cooperation in the following way: We have no Township employees, full-time or part-time, therefore we rely on the expertise of the General Assistance Secretary of the North Litchfield Township because of the size of our township. By utilizing the talents of the General Assistance Secretary of North Litchfield Township, we are able to be more efficient with the needs of the Public for General Assistance in our township.

- G. Our only office expense is our Power Bill of less than \$63.00/ month.
- H. Highway Commissioner inspects the roads of the township in his own personal vehicle at no expense to the township.
- I. Highway Commissioner picks up Trash and Debris along Rural Roads.
- J. Highway Commissioner cleans up roads and bridges after storm damage.
- K. Highway Commissioner repairs and replaces culverts and clears ditches for proper drainage.
- L. Highway Commissioner mows and maintains road shoulders and ditches.
- M. Highway Commissioner oils and applies chips to areas of the roads with the help of the oil provider yearly.
- N. Highway Commissioner maintains the 41 miles of Township Roadways as needed.
- O. Township Trustees help with Road Maintenance when oiling and chipping takes place, when storm damage occurs and when snow removal needs to be done.
- P. Highway Commissioner stores all road equipment at his home in dry, covered storage and provides his own electricity for charging batteries, maintaining, repairing and cleaning equipment with his own tools, welder and air compressor all at zero expense to the township.
- Q. All Township Roads are in good to excellent condition. Maintenance is done in a timely manner when an unsafe condition is found.
- R. The Bridges of Walshville Township are inspected by the State of Illinois, and repaired as needed.
- S. FOIA Officer handles FOIA Inquiries in a timely manner, as they arise.
- T. Township Supervisor froze levy on some tax categories because a draw was not taken from the accounts.
- U. Highway Commissioner installed a culvert for access to a cemetery within the township.
- V. Highway Commissioner gave 4 loads of rock for driveway of Kirkland Cemetery in the township.

O. What Can We Do Better or More Efficiently?

We feel we are running a very lean operation with expenses lower than any other local Townships we have checked with, in Montgomery County, Macoupin County and Madison County. We are proud to do upkeep of the township with little to no expense for the tax-payers.

P. Studies on Governmental Efficiencies

In preparing this report, we reviewed several studies on local government efficiency. These studies show that:

- Walshville Township serves 353 residents. The average local government in Illinois serves 1,800 residents.
- Most townships in Illinois have no bonded indebtedness. Together with road districts they are an integral element of local democracy. Township expenditures have grown at a Lower Rate than those of any other level of government since 1992.
- Walshville Township employs no full-time or part-time employees, therefore we have no labor costs. As a whole, Illinois Townships generally have low labor expenses.
 - Q. Our committee's recommendations regarding Increased Accountability and Efficiency:
 - 1.) Watch for grants available through the State and Federal Government to eliminate some of our operating expenses, as they become available.
 - 2.) We would like to offer a safe community place for residents in the event of an emergency. Plans for a Township Building are in the works in the near future.
